## **Information Technology Review**

As many of you are aware, we are in the process of several organizational reviews to evaluate opportunities to improve the effectiveness and efficiency of administrative services campus-wide. With regard to main campus Information Technologies (IT), an external consultant (the Technology Integration Group) is conducting the review. During the past three months, they have met with hundreds of people across campus to gather input and analyze our current IT structure and effectiveness. The final recommendations are still forthcoming, but it has become clear that we are moving toward a newly envisioned IT organization that differs in size and scope from its current structure.

Our current CIO has been effective with the current mandate, and we sincerely appreciate his service to UNM. However, we believe that moving in this new direction requires new leadership of the IT organization. We have notified the CIO that his contract will not be renewed in January, and have begun an internal search for an interim CIO to fill this position. Once an interim is in place and the consultant's report is finalized, we will hold town halls with the campus community to discuss the forthcoming recommendations and review implementation plans.

More details will be provided as they become available. I deeply appreciate the campus community's engagement in these efforts thus far. Transitions of this type are never easy, especially when personnel changes are required. Thanks again to everyone who is working so conscientiously on this and all the other review efforts.
