International Partnerships to Support UNM

Last week, I led a small delegation to Japan for a series of meetings designed to enhance an already strong partnership between UNM and the Japanese government, select Japanese universities, and key private corporations. The trip was a follow-up to a visit to UNM by the University Consortium for International Intellectual Property Coordination (UCIP), a consortium of the technology transfer offices for 11 Japanese universities.

UCIP co-hosted an international workshop that featured presentations from Professors Plamen Atanassov and Andrea Mammoli of the UNM Center for Emerging Energy Technologies, Engineering Dean Catalin Roman, and STC.UNM President Lisa Kuuttila. Additionally, we had productive meetings with the Ministry of Economic Trade and Industry (METI) and the New Energy and Industrial Technology Department (NEDO), organizations that have a long history of supporting emerging energy research at UNM.

2014 Legislative Session

Today marks the beginning of the 2014 Legislative Session. The legislature will address many issues of great importance to UNM, including the lottery scholarship, new funding formula, and funding levels for higher education in FY15. The Office of Government and Community Relations (OGCR) will be working diligently on behalf of UNM throughout the session, and will be providing updates on progress and highlights of legislative activity throughout the session. FY15 Budget Development Process Underway

The process to develop the university budget for fiscal year 2014-15 is underway. Building on the success of prior years, we are again convening the Strategic Budget Leadership Team (SBLT) to guide the process and make recommendations on budget priorities and funding levels. The charge of the SBLT has been broadened to include the implementation of the Results Oriented Management (ROM) budget model in FY15. As a result, we have expanded the membership of SBLT, increasing faculty and dean representation and adding committee members to represent the branch campuses and research office.
