Good afternoon, Lobos --

As New Mexico's only R1 institution, we understand the great importance and responsibility of the research we conduct and apply, and the great impact it can have on improving the lives of our citizens.

Last November, The University of New Mexico, in partnership with the New Mexico Higher Education Department (HED), was honored to host the launch of a new statewide initiative to research the food and housing needs of students at public colleges and universities in New Mexico and highlight resources devoted to food security at higher education institutions. This comprehensive study builds on <u>UNM's Basic Needs</u> <u>Project</u>, developed in 2020 by a team led by UNM Professor Sarita Cargas, which collected two years of data about food and shelter insecurity in our community.

And now, through Wednesday, March 1, you can help us collect even more information and data on this critical issue by participating in the <u>Human Rights Survey</u>. This survey is part of the <u>first-in-the-nation</u> <u>statewide study to assess the prevalence of food and housing insecurity among faculty, staff, and students</u>. It is the creation of a truly interdisciplinary research team of UNM faculty, staff, and students from the Honors College, College of Education & Human Science's Nutrition and Dietetics Program, College of Population Health, Anderson School of Management, and UNM's School of Law.

Your participation will provide greater context on the health of the workforce in higher education and provide a <u>greater understanding of food and housing insecurity among our students</u>. The data will be used to inform the <u>Basic Needs Grand Challenge</u> and the creation of evidence-based interventions and will directly impact the daily lives of individuals in communities across our state.

I appreciate your taking part in this survey and helping us to better understand food and housing insecurity across our state. It is in our best interests as educators, administrators, leaders, and human beings to understand the needs of our students, faculty, and staff, and to use that understanding to respond to those needs effectively and compassionately.
